Dear Parents and Carers.

You may have seen in the media the Department for Education's (DfE) announcement that schools are permitted to make Friday 18<sup>th</sup> December a 'non-teaching' day. I am writing to reassure you that we will <u>not</u> be amending our term dates or our scheduled INSET days as we recognise the significant disruption this causes our families. **This means our last day of term for pupils will remain Friday 18<sup>th</sup> December.** 

Below is an extract from the DfE guidance regarding contact tracing after school ends and a table showing the arrangements for our school:

- Where a pupil or staff member tests positive for coronavirus (COVID-19), having <u>developed symptoms more than 48</u> <u>hours since being in school, the school should not be contacted</u>. Parents and carers should follow contact tracing instructions provided by NHS Test and Trace.
- For the first 6 days after teaching ends, if a pupil or staff member tests positive for coronavirus (COVID-19), <u>having</u> <u>developed symptoms within 48 hours of being in school</u>, the school is asked to assist in identifying close contacts and advising self-isolation, as the individual may have been infectious whilst in school.
- School staff are not asked to remain on-call or conduct any contact tracing more than 6 days after the final day of teaching.
